Historical Scoring Update

The requirement is to recalculate the scoring when subject's data are updated (subjects are matched, correction of the data are made, new data are uploaded retrospectively etc..) with the current scorecard version.

Scoring can be set up to be recalculated when

- any data entity which contains subject data is updated (including snapshots)
- any data entity which contains subject data is disabled / enabled
- matching is changed

Monthly scoring recalculation was refactored without any functional changes.

Available as Change Request, performance of environment must be taken in to account if this feature can be enabled.

Big Reports Download response from WS in chunks

New WS GetCustomReportChunk method was implemented in order to be able split report response to several chunks of defined size. This will allow to download bigger reports that would not pass for example because of network limitation.

This functionality is available in all instances where Big Reports are available.

Big Reports information about limit if report not generated

New thresholds for "Big Reports" feature are introduced . This thresholds helps to identify extremely big reports. When number of data on reports exceeds this thresholds, system informs users that report may not be displayed or exported to PDF correctly. User has possibility not to continue with report generation.

- Big Report Unrenderable Threshold This is threshold for displaying of report on Front Office. When number of data entities on report exceeds this threshold, system informs users that report may not be displayed properly.
- Big Report Unrenderable Pdf Threshold This is threshold for exporting Front Office report to PDF format. When number of data entities on report exceeds this threshold, system informs users that report may not be properly exported to PDF.

This thresholds must be agreed and set up for existing instances.



Security Improvements

Several smaller security improvements were implemented

- Extension of the Authentication log with real IP from X-Forwarded-For header.
 Back Office Audit log stores now real and proxy IP address.
- Improved security by adding the http strict transport security header.

Log Out from FO after password Change

Possibility to logout from Front Office (e.g. when user is using 2 different browsers) after password change

This is security feature that we recommend to enable – available on request.

New method to get latest batch version from CBS to BTM

Currently BTM user can use new WS Batch method GetBatchVersion to get latest batch version. One call is enough to identify the latest batch version. This improvement helps with the BTM and CBS performance.

Available in the new version.

Planned for Q1 2018 release

CB5 development team is working on the following features that we can expect in the next release

- Integration to Coremetrix
- Adjustments of Administrations and Usages

We will keep you updated with the details later on.
